## **Part I RACE RULES**

The Pedigree Stage Stop Sled Dog Race (a.k.a. “Stage Stop” or “The Race”) is a limited class competition: open to all dog mushers that meet the entry requirements as set forth by the Stage Stop Organization.

The Stage Stop Organization may encourage and maintain the philosophy according to which the competition is set out to allow anyone wishing to enter and complete it to do so within the limitations of the race capacity.

The Race aims are to determine which musher's team will cover the race trail distance in the shortest time in compliance with the following regulations established by the Stage Stop:

### **Section 1 PRE-COMPETITION PROCEDURES AND ENTRY INFORMATION.**

-Participation application and entry fees are to be completed online & submitted electronically via the race website at [www.wyomingstagesstop.org](http://www.wyomingstagesstop.org)

**-Only online payments will be accepted.**

-A maximum of 20 teams may enter the competition. A waitlist be determined after 20 teams.

- All entries are subject to approval by the race committee

**-Entries will open starting on September 1<sup>st</sup>, 2024 starting at 12:00 noon MST.** There will be two windows of entry. See below for window entry definitions and criteria.

**FIRST ENTRY WINDOW:** The first entry window will run from when entries open and through midnight 12:00 PM MST on September 5<sup>th</sup>, 2024, and is open to any musher who has completed the Stage Stop Race in any year.

**SECOND ENTRY WINDOW:** The second entry window will run from September 6<sup>th</sup>, 2024, starting at 12:00 noon MST and will run through December 31 at midnight 12:00 PM MDT. This entry window is open to any qualified musher.

**Order of entries will be based off online application and payment time stamped from the web site, as a first come first serve basis.** The “race” Organization reserves the right to reject entries for just cause. Any sanctions to entrants by other races can be upheld for the PSSR.

Entry fee must accompany online entries for them to be considered complete.

One official handler for each musher must accompany them as part of their race team.

Conduct of handlers are the sole responsibility of the musher they represent. Registration for handlers is free of charge please note host families will NOT be provided.

## **Section 2 ENTRY REQUIREMENTS**

-All entrants must complete all required sections of the online race application form and submit their entry fee online via the secure online payment form in the payment section of the application.

-All applicants must be determined to be substantially qualified by the Race Marshal and may need to demonstrate their ability to manage and care for their dog team by prior race history and/or other means of accrued experience and knowledge.

## **Section 3 VETERINARY PRE-RACE EXAMINATION**

Before the competition starts, all dogs must undergo a complete physical examination which, includes a body score assessment and an orthopedic evaluation.

Examinations will be performed by the Stage Stop Veterinary Team. Veterinary Pre-Race examinations will be held Friday January 31st 2025 at 9:00 A.M. - 1:00 P.M. Drivers meeting 2:30 pm

All dogs must be examined at this pre-race veterinary examination or will not be allowed to race. **Only dogs in good health will be allowed to participate in the competition.**

All teams must arrive at the lot for examination by 9:00 am. Unless prior arrangements have been made.

\*\*\*\*\* All dogs participating in the competition must have the following mandatory current vaccinations as of January 15, 2025

These include:

Core Vaccinations (given every 3 years) which include:

Distemper

Parvo

Hepatitis'

Rabies \*\*\*\*\* PLEASE see new Rabies regulations for travel into US as of August 1, 2024

Accepted 3-year core vaccinations must have been given after March 1 2022 and before January 15, 2025.

Current Rabies vaccination certificate for every racing dog must be signed and dated by a licensed veterinarian These records must be available during the pre-race veterinary examination for the Lead Veterinarian to review before any dog will be allowed to enter the race.

. \*\*\*\*\* NEW CDC REGULATIONS FOR RABIES VACCINE VERIFICATION FOR TRAVEL INTO US. ALL DOGS MUST BE MICROCHIPPED

Other Mandatory vaccinations given annually (after March 2024 and before January 15, 2025

Bordetella

Leptospirosis

\*\*\*\* Corona virus vaccination is NO longer required for race dogs as of 2024.

It is advised that deworming your race/kennel dogs at least 3 times per year with the following products (using different products prevents resistance):

Medications which are effective for roundworms, hookworms, whipworms

Fenbendazole 50 mg/kg PO q 24 hrs. for 3-5 days *or*

Pyrantel pamoate 10 mg/kg PO *or*

Milbemycin 0.5 mg/kg PO *or*

Ivermectin 0.006-0.012 mg/kg

Medication for Giardia any

Fenbendazole 50 mg/kg PO q 24hrs. for 3-5 days

Medication for tapeworms including Echinococcus

Praziquantel 5-10 mg /kg PO

Musher must send all dog vaccination information through the website portal by January 15th, but have hard copies on hand if asked to present paperwork at the official pre-race veterinary examination. The location of the pre-race veterinary examination will be located at the parking lot at the intersection of East Deloney Ave. & North Willow Street.

All dogs not participating in the competition but carried in the musher's or

handler's truck or trailer must have the same required vaccinations as the participating dogs.

#### **Section 4 CLAIMS**

The musher agrees to hold the Stage Stop main sponsor, co-sponsor and other contributors to the Stage Stop (as distinguished from the individual mushers sponsors) harmless from any claim or demand based on any alleged action or non-action by the mushers, his dogs, agents, or others acting on his behalf. The musher also agrees to release the Stage Stop, competition sponsors and their agents and employees from any claim or demand resulting from injury to the musher, his dogs, property including, but not limited to, lost or dropped dogs and misplaced food and supplies. Furthermore, the Stage Stop has the unqualified and unrestricted authority with regards to photography and to gathering of information on the competition and all participants involved, as well as to the use of such photographs and information for advertising, public relations or any other publicity purpose related to the competition. The musher shall sign any/all documents that the Stage Stop requests in evidence the foregoing. The documents must be executed at the Mushers' Meeting.

#### **Section 5 MUSHERS' MEETING & PRE-RACE FUNCTIONS**

Mushers must attend the pre-race Mushers' Meeting, as well as any official musher banquet or function on or after Thursday January 30<sup>th</sup>, 2025, and up to the start of the ceremonial start & competition. The Race Marshall may waive the rule if a musher is delayed due to unforeseen circumstances. In any case, the musher must hold a Musher Meeting with officials prior to the official race start. A fine and time penalty will be levied if any of the aforementioned conditions are not met.

After each stage, there may be a mandatory Musher Meeting and mandatory official community function (all banquets) for all the participating mushers. Time and locations for both will be announced by the Stage Stop prior to each event.

#### **Section 6 RACE START**

**A.** The Race Organization may change the starting time and place or cancel a stage, as well as each succeeding stage due to unsuitable weather and/or trail conditions not allowing for real competition. If there is a local windchill warning in effect or if the temperature is below -20<sup>f</sup> the stage will be - either delayed till no later than 11:00am or cancelled.

**B.** The first stage (ceremonial start in Jackson, WY) will not be timed and counted, it will not become part of the musher's official race time. However, it is an official stage & must be completed in order to continue in the

race. The fastest team on stage one (first timed stage) will be required to wear the designated leader bib during stage two (second timed stage).

**C.** The starting order of the ceremonial start will be determined by the race organization. Bib numbers will be assigned based on sign-up order.

**D.** Mushers may be required to carry a junior musher participant or a dignitary musher during the ceremonial start. The race may re-order the starting order to best accommodate these riders or passengers.

**E.** The start order of each day will be based on finish order of the previous days stage, in a reverse start order. The race reserves the right to randomize the start order. This procedure will be followed throughout each stage of the race except for the first timed stage. The first timed stage starting order will be based on entry, Corresponding with the bib number.

**F.** The overall leader and/or the previous stage winner may be required to wear the designated leader bib.

### **Section 7 DOG IDENTIFICATION**

All dogs will be identified, marked and/or tagged by any marking technique deemed suitable by the race including a micro-chip placed under the dog's skin. Microchips are mandatory for travel into the US.

Mushers must list the dog's name, tag number/letter, as well as the marking technique used, on the form provided by the race.

## **Part II MAIN RACE PROCEDURES**

### **Section 8 STAGES AND CHECKPOINTS**

**A.** The distance between each start and arrival is considered a stage. The start and arrival locations are considered checkpoints. Mushers may be requested to personally sign in upon arrival at a checkpoint and may have their mandatory gear checked upon any Race Official's request at any time.

**B.** In addition to the start and arrival checkpoint, there may be checkpoints along each stage. Mushers may be requested to sign an official control paper.

### **Section 9**

#### **TWENTY-FOUR HOUR STOPS**

Twenty-four-hour stops may be scheduled during transfers and necessary rest or travel days.

### **Section 10 RACE TIMING AND STARTING PROCEDURES**

**A.** Teams will leave the starting line at defined intervals, typically three (3) minute intervals. A team not clearing the starting chute - minimum distance 100 feet (30.5 meters) shall make way for the next starting team(s) and in no way shall interfere with their progress. Any musher not able to start according to the order

drawn, will have to do so one (1) minute after the last musher scheduled to start that stage. Trail time for each team shall begin at its original start time, except teams required to start after the last scheduled musher will begin at the actual start. The Race Marshall may invoke a time penalty up to thirty (30) minutes for missed start times. If a team fails at a second attempt the Race Marshall may invoke an additional time penalty or withdraw the team. Late start teams will leave in a succeeding one (1) minute interval order. Additional time may be allowed at the discretion of the Race Marshall.

**B.** The Race Marshall may impose a mandatory stop during any stage. This includes a delay in start time due to weather or at the race marshal's discretion

This stage will be considered one stage with one total accumulated time.

**C.** To be valid, each stage and related times must be certified by the Race Marshall. The Race Marshall may refuse to certify the times and not allow a stage if he and the judges find any evidence that reveals irregularities in officiating including trail breaking, marking and timing. The Race Marshall may either cancel or request the stage to be run again.

## **Section 11 SLED**

**A.** Each musher may choose his own sled providing that it meets the necessary Stage Stop requirements, that is tandem hitch with one tow line and not fan type hitch. Braking devices must be placed between the runners and not extend beyond the length of the runners; all sleds must be provided with a brush bow, snow hook & snub-line. All parts & components of the sled must be in good working order at the start of each stage.

**B.** The sled must contain a sled bag capable of securely & safely hauling at least any two dogs in the team.

## **Section 12 SKIING BEHIND SLED**

Skiing behind the sled is strictly forbidden.

## **Section 13 MANDATORY ITEMS**

Each musher must have the following items available at each stage start and may be required by Race Officials to carry some or all of them on any stage:

### **A. Mandatory Gear**

1. A basic first aid kit containing bandages, gauze dressings, and at least one non-adhesive wrap.
2. Any promotional materials provided by the race.
3. A veterinary book provided by the race vet team.

## **Section 14 CRUEL AND INHUMANE TREATMENT**

CRUEL AND INHUMANE TREATMENT OF DOGS THAT IMPLIES ANY ACTION OR NON-ACTION, CAUSING PAIN OR SUFFERING TO A DOG WILL

NOT BE TOLERATED! FAILURE TO ADHERE TO THIS RULE WILL RESULT IN DISQUALIFICATION.

### **Section 15 MAXIMUM NUMBER OF DOGS**

A musher may start the race with no more than **twelve -12 dogs** on the tow line at any time. No dogs will be allowed to start in the basket. Dogs will be chosen from a maximum pool of Sixteen -16 dogs. No dog may be added to a team once a stage has started. The maximum number of dogs in the team may be reduced to accommodate trail conditions at the discretion of the Race Marshall.

### **Section 16 JURISDICTION AND CARE**

Dogs fall under the jurisdiction and care of the Lead Veterinarian and the veterinarian team from the time the total pool number, the number of dogs entered in the race, is declared at the pre-race vet check on the first day, until one (1) hour after the team finishes the last stage or withdraws.

### **Section 17 DROPPED/PULLED DOG**

**A.** A musher may drop dogs at designated start and arrival checkpoints. A musher may drop a dog up until the team leaves the starting line. Additionally, a team already underway may return to the starting area to drop a dog but must not hinder the progress of other teams and may be temporarily detained before being allowed to resume racing.

**B.** The Lead Veterinarian or race Marshall reserves the right to pull a dog from a team at any time. Any dog pulled by a veterinarian from the race will be identified, marked and not allowed to re-enter the race until such a time that the dog is recertified by the Lead Veterinarian. Recertification of dogs must be requested at least two hours prior to the mushers designated start time.

**C.** All dogs not running in the stage, up to the maximum allowed for a stage, and the thirteenth (13)) through sixteenth (16th) dogs, will be declared as disqualified for that stage.

**D.** Care and transportation of all dogs is the responsibility of the musher. Dogs must have bedding.

### **Section 18 DOG CARE**

In joint agreement, with the Lead Veterinarian, the Race Marshall and the Race Director may penalize a musher if the musher does not take proper care of the dogs, including dropped dogs, from the start until the end of the race. Race veterinarians may examine dogs on the teams at any time during the race. The musher or musher's handler must assist the veterinarian performing the examination or treatment of the musher's dog(s). All food and water must be ingested voluntarily by the dog, without the use of physical or medical interventions.



## **Section 19 DOG HANDLING**

A dog may not be carried by another team except during an emergency. Dogs must be carried in a humane manner and must be contained. Dogs may not be tied up behind the sled or allowed to run loose. Dogs may not be free dropped at any race staging area or the pre-race vet check parking area.

## **Section 20 SKI POLES**

Ski Poles are not permitted

## **Section 21 HARNESSSES**

The neck and breast panel of all harnesses must be padded and fit appropriately. Harnesses must always be in good condition.

## **Section 22 DRUG USE**

No injectable, oral or topical drug which may suppress the signs of illness or injury may be used on a dog. No drugs or other artificial means may be used to drive a dog or cause a dog to perform or attempt to perform beyond its natural ability. **A musher may not inject any substance into their dogs during the race.**

**Any evidence of prohibited drug use will result in disqualification from the race.**

The following drugs are prohibited:

- A. Analgesics (prescriptive or non-prescriptive).
- B. Anti-inflammatory drugs, including but not limited to:
  1. Corticosteroids
  2. Antiprostaglandins
  3. Nonsteroidal anti-inflammatories
  4. Salicylates
  5. DMSO
  6. Central nervous system stimulants
  7. Cough suppressants
  8. Anesthetics
  9. Diuretics
  10. Anabolic steroids
  11. Muscle relaxants
  12. Injectable anticholinergics
  13. Antihistamines. K. Appetite Stimulants (including but not limited to Capromorelin).

Dogs are subject to the collection of urine or blood samples, at the discretion of the testing veterinarian, at any point from the pre-race examination until two (2) hours after the teams finish the last stage. The musher or a handler will remain with the dogs. All results will be sealed and signed before the tests are considered complete.

A musher must assist the veterinarian in collecting samples whenever requested.

If blood or urine testing of a dog reveals any of the prohibitive drugs in the dog, this rule has been violated regardless of when such drugs were administered to the dog. It should be noted that current drug testing techniques can reveal substances administered up to 3 weeks before the testing. If there is any concern about medications used on the dogs prior to the race, the musher should speak to the Lead veterinarian at the pre-race vet check or the musher meeting. Also, it should be noted that some non-prescription anti-diarrheals (such as Kaopectate, Pepto-Bismol) and some herbal preparations will cause a positive drug test and therefore are prohibited. Any concerns about these preparations should be addressed prior to the race with the Lead veterinarian.

The external use of topical corticosteroids is generally limited to use on the feet. In certain cases, topical eye ointments containing steroids may be allowed by the veterinary team.

The use of megestrol acetate (Ovaban) as an estrus suppressant is permitted in intact females. This medication must be declared at the pre-race vet check and recorded by the examining veterinarian at that time. Please note that Cheque drops (mibolerone) are no longer allowed on racing dogs.

The practice of blood doping i.e. injection of whole blood, packed blood cells or blood substitutes is prohibited.

Race veterinarians may utilize any of the listed drugs or other prohibited drugs necessary to maintain a dog's health. However, such dogs will be withdrawn from the race. The use of general or local anesthetics will not be allowed in any form unless the dog is withdrawn from the race.

Personal prescriptions written for and carried by the mushers may not be used on the dogs.

### **Section 23 UNMANAGEABLE TEAM**

Mushers may receive aid to control an unmanageable team and may continue in the race providing that it does not interfere with the progress of another team. Penalties may be given either monetary or time if it is determined that impedance of other teams on the trail transpires due to unmanageable teams.

### **Section 24 FOLLOWING MARKED TRAIL**

All teams and mushers must complete the entire race as marked and check in whenever requested.

### **Section 25 DRIVERLESS TEAM**

Anyone may stop and secure a driverless team or a loose dog. The musher may recover his dogs either on foot or with another musher's help and then continue the race. Any assistance must be reported to a Race Official at the next checkpoint.

### **Section 26 TEAMS TIED UP TOGETHER**

Two or more teams may not be tied up together except during an emergency. In that case, the teams involved must notify Race Officials at the next checkpoint.

### **Section 27 MOTORIZED VEHICLES**

Mushers may not receive motorized assistance, except in an emergency. No pacing allowed. Any motorized assistance must be reported to the Race Marshall immediately upon entering a checkpoint.

### **Section 28 PASSING**

When a team catches up with another team within a distance of 50 feet, the team behind has the immediate right-of-way upon request by saying "trail". The musher

ahead must stop his dogs and hold them to the best of the musher's ability for a maximum of one (1) minute or until the other team has passed, whichever occurs first. The team which was passed may continue racing yet must remain behind for

at least four (4) minutes or one mile before the musher must request the right of way.

If the passing team becomes entangled as a result of the passing, the team's driver may require the overtaken team to stop for no longer than one (1) minute. The fastest Team has the right of way. If a team is stopped along the trail for any reason, care should be taken by the stopped team's driver to maintain an unobstructed path for oncoming teams to pass.

### **Section 29 NO MANS LAND**

The race may establish a "no man's land" on some or all stages beginning approximately one (1) mile from each finish line. This condition will be announced at the stage drivers meeting, and if so, will be indicated by a sign. Once teams enter a "no man's land", Section 29 Passing, will no longer apply. However, if a team is stopped in "no man's land", the driver must make reasonable efforts to not block the trail.

### **Section 30 PARKING OF TEAM ALONG THE TRAIL**

During the race, mushers must select a parking spot as to avoid their teams interfering with the progress of other teams.

Mushers needing to stop momentarily must not interfere with the progress of the other teams. At checkpoints, teams must be parked in locations which do not interfere with the movement of other teams and mushers.

### **Section 31 LITTER**

No littering on the trail, in camps or parking areas. Mushers are responsible for clean-up for team and self, including booties and food.

### **Section 32 OUTSIDE ASSISTANCE**

Mushers may not receive outside assistance between a stage start and finish. This includes assistance in physically guiding a team at an intersection or turn around. If a team is going to impede another team's progress, assistance may

be given to the impending team to enable other teams to continue down the race trail. A time penalty may be given

Dog care and feeding between the start and finish is the musher's responsibility only.

If there is an emergency situation, unlimited help may be given to any team. If the driver is not present, the team may be stopped and held until the driver or a Race Official claims the team. Any assistance must be reported to the Race Marshall immediately after that stage.

### **Section 33 ABANDONED TEAMS/LOOSE DOGS**

**A.** A musher who loses or abandons his team during a stage, whatever the reason, for a period of time in a location that does not allow the musher to exercise direct care and control over the team, may be required to withdraw from the Race.

**B.** All dogs starting a stage must return to the finish line either on the towline or in the basket. If the musher cannot complete the stage with all dogs in gang line or sled, the team considered DNF for that stage and will be withdrawn from the race.

### **Section 34 ONE MUSER PER TEAM**

There will be one musher per team only, no substitutions and that musher must complete the entire competition.

### **Section 35 RACE PROGRESS**

To avoid any delay in the race progress and ease the Stage Stop tasks, the Race Marshall may eliminate a team which does not complete two (2) consecutive stages within 150% of the average time of the first three teams of each of these stages.

### **Section 36 FINISH**

An official finish is determined by the nose of the first dog to cross the finish line. If a loose team crosses the finish line ahead of its musher, the team shall have finished when the musher crosses the finish line. Arriving teams are required to continue through the closed chute area past the second arrival to avoid any delaying other arriving teams.

### **Section 37 PRIZE AWARDS**

**A.** The final prize award ceremony will be held no later than 24 hours following the first team's arrival.

**B.** All mushers who have crossed the finish line up to two (2) hours before the awards ceremony must be present. The winner as well as 2nd and 3rd place mushers may be required to attend the awards ceremony together with a team dog.

**C.** Mushers must complete all stages to eligible for monetary prizes.

## **Part III MUSER'S CONDUCT**

### **Section 38 GOOD SAMARITAN RULE**

A musher may be penalized for not helping another musher during an emergency. Penalty can range from a time or monetary fines. Incidents should be reported to a Race Official at the next check point.

### **Section 39 INTERFERENCE**

No musher may tamper with another musher's dog food or gear or interfere in any manner in the progress of any other team.

### **Section 40 SPORTSMANSHIP**

Mushers shall conduct themselves in a civil, sportsmanship like manner throughout the competition. No abusive behavior towards anyone will be tolerated. Mushers will also be responsible for their handler's actions.

### **Section 41 USE OF DRUGS AND ALCOHOL**

The Stage Stop will endeavor to provide a competition that is free of those drugs and medications that could unfairly enhance the performance of the musher or might endanger the musher's animals or the musher's health. For this reason, the following drugs which are banned by the International Olympic Committee are prohibited from the competition start until the competition ends, including the prize awards ceremony.

Stimulants (amphetamines), ephedrine and related compounds (including anabolic steroids)

Diuretics

Blood doping, street drugs and pain killer narcotics, including codeine, cocaine, heroin, and hallucinogens.

Alcohol above the legal limit imposed by state traffic regulations.

Some physical disorders (i.e. high blood pressure and asthma) are commonly treated with above-listed banned drugs. (i.e. diuretics, metaproterenol and some inhalers). Therefore, mushers using these drugs should consult with their personal physician for substitute medication(s).

Under direct supervision of medical or drug testing staff, a musher may be requested to provide a urine sample 15 minutes after each day's stage.

A positive test or refusal to provide such a sample will subject the musher to disciplinary action(s).

## **Part IV RACE OFFICIALS AND PENALTIES**

### **Section 42 RACE OFFICIALS**

The Race Marshall and Judge(s) are responsible for the enforcement of all the Race Rules. ALL DECISIONS BY THE RACE MARSHALL WILL BE FINAL

- A. The veterinary staff is also responsible to assist with enforcement of dog care and treatment rules. In addition, the Lead Veterinarian is responsible to assist the race Marshall in all decisions that involve dog care and treatment.

### **B. Section 43 PENALTIES**

A rule infraction may lead to the issuance of a warning, fines, time penalties, censure or disqualification.

**Any** Race Official may issue a warning which must be reported to the Race Marshall. Time & or monetary penalties are issued by the Race Marshall.

Disqualification by the Race Marshall is based on recommendation of the other Race Officials. The Lead Veterinarian and Race Director will be included in all cases involving cruel and inhumane treatment. The Race Marshall's decision is final. Warnings may be issued for first time or minor violations

Fines may reach a maximum of US \$5,000.00 per violation and can be deducted from prize money. No musher will be allowed to participate in future Stage Stop events until fines are paid.

Time penalties of up to a maximum of five (5) hours per infraction may be issued if unintentional rule breaking gives the musher a time advantage.

Censures: The Board of Directors may censure a musher even once the race is over. A censure may be a warning and could lead to the musher's exclusion from future Stage Stop competition.

Any assessed penalty will be presented in writing to the musher.

### **Section 44 STAGE STOP ETHICS ON SPONSORING**

The Stage Stop is and must remain a race with its own ethics and with an original and particular spirit which together make up its value and interest.

The Race Organization must make sure that the spirit of the race is not deviated by events which are against such a spirit, especially as far as advertising and sponsoring is concerned.

The mushers as well as the people who for any reason participate in the Race, even if they accompany or represent the mushers or are bound to the mushers by private agreements, must behave according to the spirit established by the Race Organization and refrain from any behavior which may be against this spirit. For this reason, the mushers may not wear clothes and use equipment that are against the interest of the race or cause damage to the race organization or to the official sponsors.

The race-bibs will be attached in such a way that the number and the name or names of the official sponsors be and remain perfectly visible during the entire race. at the start, at the finish and when the prizes are awarded, both daily and final. As for the sleds, the Race Organization reserves the right to have a communication space of 36 x 24 on one side of each sled.

For the protection of each participant and for the image of the Stage Stop, every musher and handler participating in the Stage Stop gives their authorization to the race organization to supply and broadcast the photos and video footage representing the musher and his dogs taken before, during and

after the event to be used for all kinds of support, through any technical supports as much by way of reproduction as by way of advertising, and the musher allows the Stage Stop to transmit these authorized uses to other parties.

**Part V FINAL NOTE**

The intent of these regulations is to ensure a fair competition. The Stage Stop appointed Race Officials are responsible for interpreting the rules to insure that intent.
